INFORMATION CLAUSE

- Contact Form

Pursuant to Article 13, Section 1 and 2 of the European Parliament and EU Council Regulation 2016/679 of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and on repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter "GDPR"), we would like to provide you with some important information.

1. WHO IS THE ADMINISTRATOR OF YOUR DATA?

2. WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR DATA? WHY DO WE PROCESS YOUR DATA?

We process your data for the purpose of handling the correspondence you sent using the online form available on INFONET online platform, because you gave us your consent for this purpose (Article 6, Section 1, Subsection a of the GDPR). The processing is also based on the legitimate interest of the Administrator that consists in establishing, investigating, or defending possible claims.

If you agreed to receive marketing communications then based on your consent your data will also be processed for the purpose of sending commercial information or direct marketing communications (informing about promotions, offers, news, price lists, as well as promotional events, training sessions, and other activities of the Administrator) by phone or e-mail. In such case, the legal basis for the processing of your data is also the legitimate interest of the Administrator (Article 6, Section 1, Subsection f of the GDPR), which consists in conducting marketing activities for products and services that affect the recognition of the company, as well as Article 10 of the Act of July 18, 2002 on the Provision of Electronic Services and Article 172 of the Telecommunications Law of July 16, 2004.

3. WHO CAN BE THE RECIPIENT OF YOUR DATA?

The recipients of your data may be our employees and the entities cooperating with us, such as accountants, IT service providers, banks, public authorities, manufacturers, distributors, subcontractors, insurance brokers, insurers, lessors, auditors, shipping entities, occupational health and safety authorities, occupational medicine entities, cleaning service providers, alarm system servicing entities, security service providers.

4. WILL WE TRANSFER YOUR DATA OUTSIDE THE EEA?

Please be advised that we do not intend to transfer your personal data to any third country (a third country is understood as a country outside the EU and EEA). However, if your data will be transferred to a third country, we will use appropriate legal instruments to ensure the security of your data.

5. HOW LONG WILL WE PROCESS YOUR DATA?

Your data will be stored for the duration of the purposes covered by your consent or until you withdraw your consent. The data processed on the basis of the legitimate interest of the Administrator will be processed until you object such processing.

6. WHAT RIGHTS DO YOU HAVE IN RELATION TO THE PROCESSING OF YOUR PERSONAL DATA?

You have the right to access your data, rectify it, transfer it, delete it, or limit its processing. You may also object at any time, for the reasons stipulated in Article 21 of the GDPR. In addition, you may object to direct marketing in any case and at any time. If you become aware of unlawful data processing by the Administrator, you have the right to lodge a complaint to the supervisory authority (President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warszawa). You may also withdraw your consent. This, however, will not affect the lawfulness of the processing that was carried out on the basis of your consent before its withdrawal.

We do not make automated decisions or apply profiling to your data.

Providing your personal data is voluntary, but refusing to do so will prevent us from handling the correspondence initiated through the contact form, and the lack of consent to contact you for marketing purposes will prevent us from providing you with interesting commercial information or direct marketing of our unique goods and services.
